Times are tough and he would like us to consider looking at our hook up fees, Irrigation Assessment on vacant land or anything that would help. He stated he wants to continue building in Hayden but the cost difference is forcing potential buyers to buy south of Prairie. Mike stated he was going the go the City of Hayden to have the same discussion at one on their next meetings. No action was taken.
