New Business:

1. **Deduct Meter at 3520 Cranston -** There is a deduct meter attached to this property. The primary meter is at 3520 Cranston and the secondary meter is at 3576 Cranston. All use from the secondary meter is deducted from the primary meter so the customer at 3520 Cranston usage is not overstated or billed. There has been a leak at this property and due to the deduct situation the District has worked with the customer in the past to help find and repair the leak.

Billie Wolff, the owner of the property, would like to know who is responsible for the service line to the customer at 3576 Cranston. Ms. Wolff suggested 1) a dedicated line from the District to each home on her property and a dedicated line to the other property or 2) have the District add a service line directly to 3576 Cranston and then the line currently installed would be theirs or 3) the District to take responsibility for the entire service line to the secondary meter. Ms. Wolff had a document she found filed in 1913 and the District is going to have the District attorney review and explain what the document covers.

After much discussion we all agreed to meet again at the next board meeting to see what options we can come up with and find a resolution which works for both parties.
