ANNUAL IRRIGATION ASSESSMENT

Tract Fee	\$35.90
Maintenance	\$54.54 Per Acre or Less
EPA/DEQ	\$10.00

Total \$100.44 for lots 1 acre or less.

Lots greater than 1 acre, multiply additional acreage by \$54.54 and add to \$100.44 for total.

Irrigation Allotment: 326,000 Gallons per Acre or Fraction Thereof

Irrigation Overage \$1.62 per 1,000 gallons over allotment

Irrigation Assessments are billed in the fall and are due by December 20th of that year. If the first half is paid by December 20th, then the second half is due by June 20th of the following year. No statement is sent for the second half. Failure to pay the irrigation assessment will result in penalty and interest at the stated rates below under Terms of Payment.

TERMS OF PAYMENT

All past due balance (balance forward) and current charges are to be paid by the due date. All payments received will be posted to oldest invoice first. Payment methods – cash, check, credit/debit cards. We accept cash and checks in the office or via mail. We also accept credit/debit or checking/saving payments on our website or by calling the phone number listed below; there is a flat rate fee charged by the payment provider. We have a slot in our front door for after-hour payments.

If you elect to pay using your bank on-line system, please note some banks issue checks and it can take up to 10 days for us to receive your payment. If you receive a late notice and your payment is not received, at the District, by the date specified, a door tag will be hung for service disconnection and you will be charged the appropriate fees.

Late Fees are applied to accounts on the fourth (4th) business day after the due date.

Delinquent Accounts will be charged the following:

Late Fee: \$15.00
Penalty: 2% of past due balance
Interest: 1% per month on past due balance
Door Tag Fee: \$20.00
Services disconnected for non-payment: \$25.00

The District will post a disconnect notice on the door with date and time for disconnection before service is disconnected and a door tag fee is applied at this time. Accounts must be paid in full before service can be restored. If a second notice is posted, it will be for a maximum of 24 hours before disconnection and there will be an additional Door Tag Fee.

Domestic bills are sent at the beginning of the following months and are due by the end of that month:
