TERMS OF PAYMENT 2025

All charges are to be paid by the due date listed on the invoice or late fees will be applied. Payment methods include cash, check, and credit/debit cards. We accept cash and checks in the office or checks via mail. We also accept credit/debit or checking/saving payments on our website or by calling the phone number listed below; there is a flat rate fee charged by the payment provider. There is a drop box available at the District office available 24/7.

If you elect to pay through your bank, please keep in mind some banks issue checks and it can take up to 10 days for us to receive your payment. If you receive a late notice and your payment is not received, by the District office, by the date specified, a door tag will be hung for service disconnection and you will be charged the appropriate fees.

Late Fees are applied to accounts on the fourth (4th) business day after the due date.

Delinquent Accounts will be charged the following:

Late Fee: \$15.00

Penalty: 2% of past due balance

Interest: 1% per month on past due balance

Door Tag Fee: \$20.00

Services disconnected for non-payment: \$50.00

The District will post a door tag on the door providing the date and time of the disconnection before the service is disconnected. If a door tag is received, the account will receive a door tag fee. If the service is disconnected the account will be charged a \$25.00 lock off fee and \$25.00 to turn the water back on. Accounts must be paid in full before service can be restored.
